DURING THE FISCAL YEAR ENDED JUNE 30, 2019, the organization provided outpatient primary services to approximately 40,155 un-duplicated clients (2,942 Homeless clients). Over 92% of the individuals were at or below the poverty level. The medical department provided 68,214 visits, the dental department provided 37,424 visits, the optometry department provided 14,170 visits, the chiropractic department provided 1,871 visits, and behavioral health provided 2,168. The homeless department provided 4,709 visits.
